2017 TCC Voting Delegate Appointment Resolution

Background. Act 32 § 505(b) requires the governing bodies of school districts, townships, boroughs, and cities that impose an earned income tax to appoint one voting delegate and one or more alternate delegates to be their Tax Collection Committee (TCC) representatives. The purpose of this resolution is to appoint the required delegates. The appointed individuals have consented to appointment.

RESOLVED, by the governing body of the Sharpsville Area School District that the following individuals are appointed as TCC delegates for the Sharpsville Area School District:

1. Primary voting delegate: Business Manager/Board Secretary

2. First alternate voting delegate: Superintendent

3. Second alternate voting delegate: Finance Committee Chairperson

- 4. If the primary voting delegate cannot be present for a TCC meeting, the first alternate voting delegate shall be the representative at the TCC meeting. If both the primary voting delegate and the first alternate voting delegate cannot be present for a TCC meeting, the second alternate voting delegate shall be the representative at the TCC meeting.
- 5. These appointments are effective January 1, 2016 and shall continue until successors are appointed. Delegates shall be appointed each year in November or December or as soon thereafter as possible. All delegates shall serve at the pleasure of this governing body and may be removed at any time.

DECLARING THE OFFICIAL INTENT OF THE BOARD OF THIS SCHOOL DISTRICT TO ISSUE BONDS OR NOTES FOR RENOVATIONS, ADDITIONS, CONSTRUCTION AND IMPROVEMENTS TO THE MIDDLE SCHOOL AND HIGH SCHOOL, AND TO REIMBURSE ITS CAPITAL RESERVE ACCOUNTS AND GENERAL FUND FOR EXPENDITURES MADE FOR SUCH PROJECTS.

WHEREAS, the Board of School Directors (the "Board") of this School District is contemplating undertaking a capital project or projects that will consist of the renovations, additions, construction and improvements to the Middle School and High School of this School District (the "Project"); and

WHEREAS, this School District is also contemplating incurring debt in an estimated amount of up to \$8,720,000.00 in connection with the Project, such debt to be evidenced by general obligation bonds or notes of the School District (the "Obligations"); and

WHEREAS, the Board has determined that it may be necessary or appropriate to pay initial costs and expenses of the Project from money held in accounts within the General Fund or Capital Reserve Accounts of the School District, that may be available temporarily for such purposes before the Obligations are issued, but it is not the present intent of the Board that such General Fund or Capital Reserve Accounts money be used as the permanent source of money to pay such costs and expenses; and

WHEREAS, the federal Internal Revenue Code of 1986, as amended, and related tax regulations impose certain restrictions upon the use of proceeds of tax-exempt obligations to reimburse the issuer for costs and expenses previously paid, unless the issuer has made a declaration of official intent to reimburse itself for such costs and expenses before they are paid or within 60 days after they are paid.

NOW, THEREFORE, BE IT RESOLVED:

- 1. The Board hereby expresses its intent to proceed with the Project and to issue the Obligations in an aggregate principal amount currently estimated not to exceed \$8,720,000.00 to provide permanent financing for the Project; provided, however, that for purposes of economy, the Board may elect to combine the costs of the Project with the costs of other capital projects or the refunding of outstanding bonds or notes of this School District for purposes of financing.
- 2 The Board hereby declares its reasonable expectation that proceeds of the Obligations shall be allocated to reimburse the Capital Reserve Accounts or the General Fund of this School District for expenditures made for and toward costs and expenses of the Project prior to the issuance of the

Obligations, including (if applicable) any costs and expenses of the Project paid out of such Capital Reserve Accounts or General Fund hereafter, or within the past 60 days, and any preliminary costs and expenses of the Project that are eligible for reimbursement under the provisions of the Internal Revenue Code and applicable regulations cited below.

3 The Board hereby declares that this Resolution shall constitute a "declaration of official intent" within the meaning of Section 1.150-2 of the Treasury Regulations promulgated by the Internal Revenue Service under Section 150 of the Internal Revenue Code of 1986, as amended.

Section 2. This Resolution shall become effective upon adoption by the Sharpsville Area School District's Board of School Directors and shall be on-going and continue for so long as the above-named non-profit organization operates any small games of chance authorized by and consistent with all applicable ordinances, statutes, and regulations now in effect or amendments subsequently enacted.
